



Passport and Visa

Passport and Visa Information

All persons visiting Saudi Arabia must be in possession of a passport valid at least six months beyond their estimated stay.

Certain occupational designations are sensitive to the Saudi Authorities and can cause undue delays sometimes resulting in the refusal of Visa issue, it is therefore advisable to check this point with the recommended agent.

Visas are not required by GCC nationals. All other nationalities require a Single Entry Visa to enter Saudi Arabia.

Women delegates under 35 years are unlikely gain visas to enter Saudi Arabia, though this depends on the status.

It must be noted that any person holding a passport with any indication of travel to Israel will result in refusal of entry to Saudi Arabia.

OBTAINING A VISA INVOLVES RECEIVING A LETTER OF INVITATION OR A VISA NUMBER FROM SAUDI ARABIA TO ENTER THE KINGDOM.

First, complete the enclosed Visa Application Form and Email it to SunaidiexpoForm@sunaidiexpo.com making sure that you clearly indicate the city in which you will collect your Visa.

When your application is processed by Sunaidiexpo, a Letter of Invitation (or visa number) will be faxed to the Consulate Section of Embassy of Saudi Arabia in your country which you designated. A copy will also be forwarded to you, the applicant who will serve to notify you that your Consulate has received the Letter of Invitation (Visa Number).

All visitors to Saudi Arabia are strongly advised to carry their passports at all time.

Note:

1. Visas for females cannot be applied for as exhibitors or visitors
2. Kindly ensure that exhibitors do not have an entry stamp on their passports from the Govt. of Israel as they will not be admitted to the Kingdom of Saudi Arabia.
3. The Organizer will fill the above particulars in special forms and apply to the Ministry of Foreign Affairs. If approved the organizer will receive a Visa No. or letter of invitation (where applicable) that will be faxed to the exhibitor.
The Exhibitor will then do the necessary visa formalities at the Saudi Embassy or Consulate in the Country, to which the Visa has been sent to stamp the Visa on the passport prior to travelling.
